The procedure is as follows:

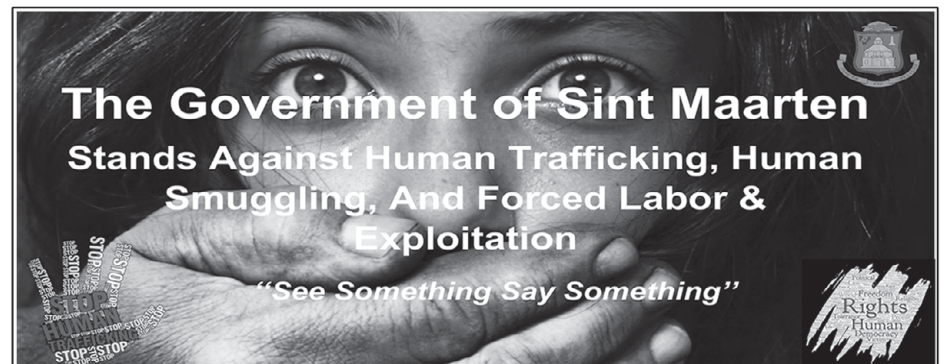
1. You can fill in the re-registration form by clicking on the link <https://forms.gle/saV3xJrvGLqUKy288> or by scanning the QR code
